- 1. Approve meeting notes
 - a. Ali Morrison & Katie Mobley approved as written
- 2. Track Update
 - a. Waiting for the seed to fall, hoping to have the fence taken off by 10/26 but dependent on grass and mowing
 - b. Taking out the flags and lowering heads for the water system
- 3. Bond Update
 - a. 3 different project managers to work with us on the bond package
 - b. Vestibule: architects sent to look, plans have been sent
 - i. Get in through the main door and door through vestibule into the office, have to get buzzed in through the office to get into the rest of the school
 - ii. Working on it this summer for completion in September
 - c. Putting film on windows to make sure the glass doesn't shatter and so people can't see directly in
 - d. 6 foot fencing all the way around the property, will be a maintenance gate by Meridian Park and the original maintenance gate
 - i. Supposed to be starting in the summer
 - ii. Wrought-iron look?
 - iii. Ask about outdoor classroom being fenced in
 - e. Did a walk-through for the chiller, water heater, and roof
 - i. Getting a new chiller and water heaters, some of the drains are not allowing water to drain and it is eroding the roof
 - f. Going to look at what the bond covers and prioritize
 - i. Water is eroding our foundation, it needs to be watered and taken care of
- 4. Special Education Update and Professional Development

- a. Baldwin is looking better in the evaluation process than we have since prior to covid
- b. Some concerns about the professionalism and thoroughness of the evaluations
- c. Teachers being asked to do 36 hours of PD because of TEA, 2 monitors are helping AISD through the process
 - i. Have done 1 day, need 2 more days with 100% of staff participation
 - ii. If we don't hold up our part of the agreement, TEA can take over AISD
- d. Baldwin is fully staffed for SPED
- e. Kids with dyslexia are going through the FIIE process and are required to have an IEP now, putting a lot on SPED teachers

5. Campus Improvement Plan

- a. Staff survey having to do with the sense of belonging for individuals
 - i. Not necessarily low numbers, but the lowest from the data
 - ii. Led to discussions of what the word belonging means
 - iii. Working on how to improve the climate at the school
- b. Comes from STAAR data (identifying gaps for emergent bilinguals, sped and eco-dis),
 - Focus area/desired annual outcome with 3 strategies on how to meet that
 - ii. Discusses who will help
 - iii. Using common assessments, MAP testing, observations (data binders) to show results
- c. Still in draft form if anyone sees ways to improve it

6. Vocabulary Parade Route

- a. They are going to open the gates in the pavilion, Watchdogs will be here
- b. PTA will have donuts and coffee for FREE

7. Continued talk on budget

- a. Really short on money, looking for about \$10,000 to finish paying the interventionist
- b. Perhaps next year we can ask PTA to help us with some of that,
 but will have to work with PTA on that

- c. Made \$18,000 less than we needed to pay our interventionist at Fun Run
- d. Being thoughtful about how to spend money
- e. Can we move the beautification money?
- f. Ink: going to 1 printer for each grade level, buying one high-capacity/high-impact cartridge (\$125 each)

8. Safety Conversation

- a. Weekly door checks of every door on campus, make sure all of the handles are working and send in a special work order if they are not
 - i. Incorporated into the watchdog duty (3-4 times per week)
- b. For the Thanksgiving lunch, we have to make sure every parent checks in with the office and has a badge
- 9. Human Sexuality and Responsibility Curriculum
 - a. Next principal coffee talk, will be available to see the curriculum
 - b. Curriculum has not changed, kids have to opt-in to get the lessons
 - c. Girls and boys who opt in will still be together
 - d. Firm deadline to opt-in
- 10. New Business
